The House that Lulu Built **Comforts Grieving Families**

A peaceful presence fills The House that Lulu Built in Greenville, warmly welcoming families who are grieving the loss of a loved one. The home is available at no cost for day or night stays during the funeral, offering comfort, compassion and convenience. Since opening in 2019, The House that Lulu Built has received over 100 families who have found solace in being together in a home-like setting. The house is located within ¹/₂ mile of Greenville's two funeral homes.

Jason and Cami Snyder of Greenville established The House that Lulu Built in memory of their infant daughter Lulu, born 13 years ago. Having an extra chromosome, Lulu lived just 2 months, but her legacy continues through the generous efforts of her family and community.

"Sharing Lulu's story helps us connect with others who are on their own grief journey," said Cami. "Connecting with others helps us know we are not alone. It was important to us to do something tangible with our grief and lead by example to our other 4 children. We learn step by step how to walk through difficult times."

Buying the home and completing renovations came from a heartfelt commitment the Snyders made to keep Lulu's spirit alive. The Snyders have poured their own resources into their mission, and they generate community support through gifts, in-kind services, and fundraising events.

Families learn about Lulu's House through local funeral homes, churches, and the public.





Fund Options Help Donors Meet Their Charitable Goals

At the Darke County Foundation, people from all walks of life donate to charitable causes they believe in. Donors can support scholarships to local students or provide assistance to organizations that serve Darke County residents. Whether donors establish a personalized fund or add to an existing fund that matches their interest, they are enriching and improving our community!

Donors often create lasting legacies by naming a fund after loved ones or a specific purpose that is important to them. Then grants are made in this name for years to come. The following types of funds are available at the Darke County Foundation. For more information, call us at (937) 548-4673.

Unrestricted Community Fund: This type of fund offers the broadest reach and most flexibility, strengthening programs that address the changing needs of our community. For example, our Friends of the Foundation Fund is bolstered by hundreds of donors each year who give any amount they wish. Friends' gifts help fill grant requests from local charitable groups.

Donor-Advised Fund: Donors are actively involved by recommending grants periodically to a variety of charitable organizations. The grants are made in the name of your fund. Donor-advised funds offer the benefits of a private foundation while leaving the administration to the Darke County Foundation.

Designated Fund: Donors name one or more charitable organizations to receive automatic annual distributions, benefiting specific groups that are close to the donor's heart.

Field of Interest Fund: Donors interested in a certain cause (like youth programs, the arts, mental health, etc.) or geographic area (like a town) may set up a fund to award grants that further these interests. Grants are not restricted to one organization.

Scholarship Fund: These funds provide financial assistance to any level of education (such as college freshmen, upperclass students, or vocational school). Donors may determine criteria such as a specific high school, fields of study, colleges, or extracurricular activities.

Project Fund: Established by a group of individuals to support a community need, project funds collect donations from the public then distribute the principal to the project.

Organization Fund: Non-profit organizations may set up a fund to provide ongoing support to its own organization. In so doing, the Foundation helps organizations manage their assets.

Scholarship Honors Kathleen Floyd

The Darke County Foundation has established a new scholarship fund in memory of (Mary) Kathleen Floyd of Greenville.

Mrs. Floyd taught at St. Mary's Catholic School, Greenville, for 23 years (1973-1995). She also taught at Edison State Community College as an adjunct professor for 19 years (1987-2006). She then served on the college's board of directors.

The scholarship is for a graduating senior from any Darke County high school who attended St. Mary's Catholic School.

Mrs. Floyd's family established the scholarship to honor her legacy as a loving wife, mother, grandmother and teacher. As a permanent endowment, the fund will provide an award in Mrs. Floyd's name every year. Her

commitment to teaching, particularly language arts, reflected the value Mrs. Floyd placed on education. From 1960 through 1973, Mrs. Floyd wrote a weekly column, "All Around the House," in the Greenville Daily Advocate. Readers enjoyed her humorous stories of life with her husband Bill and their 8 children. From 1995 to 2020, Mrs. Floyd wrote "Back Around the House."

Mrs. Floyd was dedicated to the Greenville community, serving on Greenville City Council for 3 terms. She was on the boards of Family Health Services, Greenville CIC, Downtown Greenville, Inc., Community Action Partnership, the Boys and Girls Club, and Darke County Center for the Arts.

IRA Distributions Save Taxes and Help the Community

When December rolls around every year, a Darke County couple makes their Christmas wish list. The wishes aren't for themselves, but for charitable programs that have made an impact on their lives. The donors give away about \$25,000 through a designated fund they established at the Darke

County Foundation.



The couple doesn't want any recognition for the good they do in our community, so they asked to remain anonymous.

"We don't donate in order to be recognized," they said. "We donate because we

believe in supporting good causes where others can use a little help."

This generous couple could represent any number of donors in Darke County, no matter the amount they give. Our community is filled with people who want to further meaningful causes but don't want their name printed.

Each year, this particular couple replenishes their charitable fund with distributions from their IRA accounts. Because they are over age 73, the couple has minimum distributions required by law. When they transfer the amount directly to the Darke County Foundation, a qualifying charity, the amount is not counted as income and thus not taxed.

"I love America and support America, but I won't give America all my tax money," quipped the donor.

Local groups benefiting from the couple's generosity include The House that Lulu Built, EverHeart Hospice, St. Mary's Church, and Greenville City Schools. The couple also sponsors scholarships for students pursuing healthcare and education degrees.

The Darke County Foundation charges no administrative fee for this "pass-through" gift-giving. Beneficiary organizations can be inside or outside Darke County. If you have a required IRA distribution, you can support causes close to your heart while also reducing your taxes. The Darke County Foundation can help fulfill your charitable wishes, whether you want to be identified or not!
